Football Clinic Waiver and Release

In exchange for being permitted to attend and participate in activities related to the Jordan McNair Foundation football clinic (the "Event"), the Player, or the Guardian (on behalf of the Player), hereby agrees to the following:

I acknowledge that I, or one or more minor Players for whom I am responsible, will participate in athletic activities at McDonogh School including, without limitation, jogging, running, throwing, catching, stretching, hitting, and tackling ("Activities"), and that participation in the Activities presents risks of physical injury, harm, and/or death. I acknowledge that the Activities have inherent risks, hazards, and dangers which include, without limitation: (a) accidents; (b) environmental injuries; (c) inclement weather and extreme temperatures; (d) the actions and omissions of others participating in Activities at the Event; and/or (e) the unavailability of immediately obtaining medical attention in the case of injury. I understand the risks, hazards, and dangers described above. On behalf of myself, or any minor Player for whom I am responsible, I hereby expressly assume and accept all such risks, including the risk of loss, damage, or injury occurring as a result of visiting and/or participating in the Activities at the Event.

On behalf of myself, or any minor Player for whom I am responsible, and my or our heirs, successors, executors, representatives, I hereby voluntarily, knowingly, intentionally, irrevocably and unconditionally waive, release and discharge the Jordan McNair Foundation and the McDonogh School, including their agents, volunteers, employees, directors, and officers (collectively, the "Released"), from any and all claims, damages, obligations, liabilities and expenses (including, without limitation, attorneys' fees) that arise out of or are related to the Activities, whether foreseen or unforeseen, including, without limitation those for personal injury, death or property damage, and/or theft or destruction, except for those injuries that result from the Jordan McNair Foundation's and/or McDonogh School's willful or gross negligence. I further waive all relief, whether legal or equitable, that I, or any minor Player for whom I am responsible, or any of his or her other legal guardians, parents or assigns, may be entitled to seek from either the Jordan McNair Foundation or McDonogh School, including, without limitation, compensatory damages, punitive damages, attorneys' fees, expenses, and costs. I also agree to indemnify and hold the Jordan McNair Foundation and McDonogh School harmless from all claims, judgments, and costs, including attorneys' fees, incurred in connection with any action brought as a result of participation in the Activities by myself or the minor Player for whom I am responsible.

I represent that I have full right, power and authority to sign this Release and to bind myself and/or any minors to its terms. I have carefully read, clearly understand, and voluntarily signed this Release.
